

Oral History Interview Release Agreement
Bering Strait School District - Koyuk IRA Council - University of Alaska Fairbanks

Several adult residents and students from Koyuk are currently taking a University of Alaska Fairbanks Northwest Campus course entitled *Digital Documentation of Cultural Knowledge* (CIOS 193). In this course, students learn techniques for documenting and preserving traditional knowledge and cultural heritage. Students will be conducting interviews with local residents, scanning images, photographing and filming. Final projects will combine audio and images in multi-media presentations which will be shown to the community. Copies of the projects will be provided to participants, the Bering Strait School District, University of Alaska Fairbanks, the Koyuk IRA Council and the Kawerak Eskimo Heritage Program.

This interview release agreement covers two important issues:

1. This class project recognizes traditional Inupiat values regarding appropriate use of cultural knowledge and oral history. Before participating in this project, individuals should know that both the original recordings and the finished programs will be available to the public for educational and research purposes. Copies of the recordings and the final projects will be available the Bering Strait School District, University of Alaska Fairbanks, the Koyuk IRA Council and the Kawerak Eskimo Heritage Program. Students wish to avoid recording information that is not appropriate for public use.
2. This release agreement insures that the students and partners involved in gathering these recordings are entitled to use the recordings and the final student projects for non-commercial, educational purposes according to their existing public use policies. Broadcast or use for commercial purposes is not permitted without written permission from the other partner organizations.
